- [1] **ON READING** the *Application for Bankruptcy Order* (the "**Application**") of Alaris Royalty Corp. (the "**Applicant**"), as well as the exhibits and affidavit filed in support thereof;
- [2] **CONSIDERING** the service of the Application;
- [3] **CONSIDERING** the submissions of the attorneys present at the hearing;

[4] **CONSIDERING** the absence of a notice of contestation pursuant to section 74 of the *Bankruptcy and Insolvency General Rules* and the absence of contestation of the issuance of a bankruptcy order against Bernard Poulin (the "**Bankrupt**");

[5] **CONSIDERING** the provisions of the *Bankruptcy and Insolvency Act* (the "**BIA**");

**THE COURT:**

[6] **GRANTS** the Application;

[7] **ORDERS** that the Bankrupt be adjudged bankrupt by virtue of the present Bankruptcy Order (this "**Order**");

[8] **ORDERS** that Raymond Chabot Inc. (the "**Trustee**") be appointed as trustee of the estate of the Bankrupt;

[9] **ORDERS** that this Order shall have full force and effect in all provinces and territories in Canada against all persons, firms, corporations, governmental, municipal and regulatory authorities against whom it may be enforceable;

[10] **AUTHORIZES** the Trustee to issue a summons to the Bankrupt to be examined pursuant to section 163 BIA;

[11] **AUTHORIZES** the Applicant or the Trustee to effect service upon the Bankrupt of:

(a) this Order; and

(b) a summons to appear to be examined by the Trustee pursuant to section 163 BIA,

at 28 Beloeil Avenue, Outremont, Quebec, H2V 2Z3 or 301 Merry Street South, Magog, Quebec, J1X 4Z9 by delivery to the Bankrupt personally or to a reasonable person at either of those addresses, by leaving it in a mailbox at either of those addresses or by any other appropriate means, with a copy by email to his personal email address: [bpoulin123@icloud.com](mailto:bpoulin123@icloud.com);

[12] **ORDERS** that the costs of and incidental to this Application and Order be paid to the Applicant out the estate of the Bankrupt on taxation of the estate.
