[1] CONSIDERING the Applicant's Application for a Second Extension of the Stay of Proceedings and Other Reliefs dated July 26, 2024 (the "Application");

**GIVEN** the allegations of the Application, the sworn statement filed in support therewith, the third report of the Monitor dated July 25, 2024 (**S-6**), the testimony of the representative of the Monitor and the absence of contestation;

## WHEREFORE, THE COURT:

- [3] GRANTS the present Application for a Second Extension of the Stay of Proceedings and Other Reliefs dated July 26, 2024;
- [4] ABRIDGES the delays of presentation of the Application;
- [5] **EXTENDS** the Stay Period (as defined at paragraph 8 of the Amended and Restated Initial Order dated March 21, 2024) until **October 31, 2024**;
- [6] PRAYS ACT of the Assignment and subrogation agreement between Royal Bank of Canada and Dice Pizza S DE RL DE CV dated July 10, 2024;
- [7] PRAYS ACT of the Assignment and subrogation agreement between Gestion Pierre Sabourin inc., Robert Bouchard, Robert Joyal et Denis Pilon, et Dice Pizza S DE RL DE CV dated July 17, 2024;
- [8] PRAYS ACT of the Assignment and subrogation agreement between National Bank of Canada and Dice Pizza S DE RL DE CV dated July 18, 2024;
- [9] MAINTAINS the stay of proceedings in the court file bearing number 500-17-126063-232 until the Restructuring (as defined at paragraph 27 of the *Amended and Restated Initial Order* dated March 21, 2024);
- [10] INCREASES the Interim Facility (as defined at paraph 20 of the *Amended and Restated Initial Order* dated March 21, 2024) by \$75,000.00 as well as the Interim Lender Charge (as defined at paragraph 22 of the *Amended and Restated Initial Order* dated March 21, 2024) by \$75,000.00;
- [11] ORDERS the filing under seal of Exhibit S-3 to be kept confidential and sealed until further order from this Court;
- [12] ORDERS the provisional execution of the present Order notwithstanding appeal;

## [13] THE WHOLE without costs.
