1. On October 31st, 2024, pursuant to an Order issued by the Ontario Superior Court of Justice (Commercial List) (the “**Court**”), Raymond Chabot Inc. was appointed as receiver and manager (the “**Receiver**”) of all of the assets, undertakings, and property of Korson Furniture Imports Limited (the “**Company**”) acquired for or used in relation to a business carried on by the Company, on application of the secured creditor, Caisse Desjardins Ontario Credit Union Inc.
